Chapters 48 & 938; The Children's Code and Juvenile Justice Code

Ch. 48 evaluations pertain to child welfare and safety concerns, and are usually requested when there are questions regarding mental health issues and behavior, diagnosis, caretaker/parent mental health or AODA issues.

Ch. 938 pertain to youth involved in the juvenile delinquency system and are usually requested when there are questions regarding mental health issues and behavior, diagnosis, placement recommendations, and treatment recommendations.

Evaluation types can include: Psychological evaluations on children & parents, Neuropsychological evaluations, Psychosexual evaluations, Bonding and Attachment Assessments, Psychiatric Evaluations, AODA Assessments

Necessary Evaluator Credentials: PhD or PsyD, MD, Master's Level Clinicians (AODA evaluations only)

Evaluations occur within the community and occasionally in secure settings like Juvenile Detention Center. Court testimony is occasionally requested, and evaluators are compensated for their time in testimony.

Chapters 54 & 55; Adult Guardianship and Protective Placement

Evaluation requests pertain to matters of guardianship and protective placements for adults in need. Evaluations can require a Master's Level clinician, PhD or PsyD, or MD depending on the evaluation criteria.

Evaluations occur in the community, at individual's place of residence or assisted living facilities or care centers.

Court testimony is occasionally requested and evaluators are compensated for their time in testimony.

Chapter 51; Emergency Detention and Involuntary Commitment for Treatment

Evaluation requests pertain to mental health assessments of individuals recently committed to an inpatient hospitalization or to individuals who are being monitored in the community while on a Commitment Order.

Necessary Evaluator Credentials: PhD or PsyD, MD

Evaluations occur at hospitals or institutions (Winnebago Mental Health Institute, Mendota Mental Health Institute, Stoughton Hospital, St. Mary's Hospital, Meriter Hospital, UW Hospital, Badger Prairie Health Care Center). Evaluations can also occur in the community for individuals on Commitment Orders.

Court testimony is frequently requested (phone or in person) and evaluators are compensated for their time in testimony.
