Our services provide education, support, stabilization, and coordination of care to children, families, and individuals in our community. RISE emerged in April 2017 from a merger between Community Partnerships, Inc. and Center for Families, two Dane County non-profits focused on community-based, strengths-driven services to children, families, and young adults. With the merger between these two organizations in 2017, RISE brings over 40 years of experience and services to the community and is one of the only agencies in Dane County that can provide a continuum of care from the time a child is born until early adulthood. RISE serves **3,300 children**, individuals and families in Dane County each year.





CONTINUING TO WITHSTAND CRISIS DURING A PANDEMIC:

THE DIRECTOR'S NOTES

2020 provided an opportunity for our community to come together. While the pandemic shocked the world, it shed light on the importance of being adaptable, particularly as a community serving organization.

We know what it is like to respond to a crisis and the need to shift at a moment's notice. This is what RISE does, we are built for a crisis and are able to walk alongside children, young adults and families when their life takes a turn and when they are in turmoil.

Our ability to adapt served us well when we shifted our operations and service delivery to a virtual environment in March, and we continued to adapt throughout the year. We continued to meet the needs of participants and families in the most safe and effective ways possible:

- The Respite Center quickly modified their childcare space and kept its door open to support families at the highest need of respite,
- ParentChild+ delivered educational materials to the family's home and provided remote learning to assist the parents and caregivers in engaging in literacy activities,
- Welcome Baby and Beyond and the Early Childhood Initiative quickly turned to virtual options to provide early childhood development and caregiver support, developmental and mental health screeners, housing, employment and educational services, etc.
- Court Ordered Evaluations program continued to work with our circuit court partners to provide mental health evaluations critical to assisting with the best treatment options and alternatives.



 Children Come First, Comprehensive Community Services, Parent Peer/Peer Specialist and Therapeutic Services Team continued to provide much needed mental health services in a manner that met the needs of the participant, i.e. outdoor walks or telehealth options. RISE also advocated with other providers to allow Medicaid reimbursement for telehealth.

In partnership with United Way of Dane County we distributed \$25,000 in funds across our programs to help families pay rent, put food on their table, receive educational and enrichment materials for their children and supported families to remain safe and stable. Other donors and the philanthropic community also stepped up and supported organizations like RISE to continue to deliver on our missions.

Although not new, we were faced with a new challenge, and we leaned in. Together we were able to RISE and support those at highest risk.




